A History of the Arlington County, Virginia, Department of Health. The First Forty Years, 1919-1959. Arlington, 1961. 29, x p. (Begun in 1919 when the county name was still Alexandria, the Department of Health was one of the first full time county public health departments established in the United States. This booklet reviews its progress and development from those pioneering days, touching on such topics as water and sewerage systems, child health programs, communicable diseases control and the associated work of unofficial agencies.)

(Tentative inventory of old records found in Court House, after they had been arranged. Illus., diagrs. (Discusses design of bascules, their erection and problems encountered in securing adequate material for counterweights.)
